Thank you for writing to share your views with me about telecommunications. Broadband Internet networks that serve consumers play a critical role in California and throughout the world. California is the most interconnected state in the country and is home to many of its most significant innovators.

Telecommunications companies provide services that Californians rely upon daily. These networks connect friends and loved ones, connect businesses to customers, connect students to learning, and connect us to the latest news from around the world. And, right now, companies are innovating to develop even more powerful services to connect consumers – including connecting devices to each other through the Internet of Things – in exciting new ways that were not imaginable just a few years ago.

I am committed to creating an environment where innovators can flourish and where consumer protections remain top of mind as technology advances. Telecommunications companies store enormous amounts of data from their customers, including email, financial records, Internet browsing history, and health records. Companies have a responsibility to ensure that these data are well protected and shielded from unauthorized disclosure.

For these reasons, I voted against a Senate resolution (S.J. Res. 34) in March 2017 that repealed a Federal Communications Commission (FCC) rule giving consumers privacy protections against the sale or use of your data without your permission. The rule would have placed reasonable requirements on Internet service providers (ISPs), including telecommunications companies, to seek permission from consumers before collecting sensitive information and to require them to implement security protections to protect consumer data. This was a common-sense rule that should have been maintained. I was disheartened that a majority of my Senate colleagues voted for the resolution and the president signed it into law.

Nevertheless, I will continue to work to make sure both innovation and consumer protection thrive in the telecommunications sector. As your Senator, I will continue to reach across the aisle and work with all members of the Senate to help make progress on this goal.

Thank you for contacting me with your views on our immigration system.

In my career as a prosecutor in California, I saw the full spectrum of criminal offenses. I know what a crime looks like. And despite the Trump administration's rhetoric vilifying immigrants as criminals, I can tell you that being an immigrant is not a crime.

The Trump administration has pursued immigration policies based on fear rather than facts and threatened core American values in the process. It has cruelly separated thousands of children from their parents who are seeking asylum at the border, fostering long-term trauma for these children, and then attempted to use the resulting crisis to seek the indefinite detention of immigrant families. It has broken a promise to thousands of young Dreamers and callously held them hostage to its pursuit of an untenable, extreme, and costly immigration legislative agenda. It has indiscriminately expanded immigration enforcement within American communities, failing to distinguish Dreamers and other hardworking individuals with no criminal backgrounds from actual public safety threats. This has torn families apart, harmed our economy, and created a culture of fear that has reduced the willingness of community members to report crimes and serve as witnesses, endangering public safety for everyone.

As a member of the Senate Judiciary and Homeland Security Committees, I have and will continue to work tirelessly to hold the Trump administration accountable for these and other immigration policies and practices that harm our communities and threaten our nation's global humanitarian leadership. I have pressed administration officials to preserve the unity of families and to protect the rights of vulnerable populations. Thank you for contacting me to voice your concern regarding the United States' military support for a Saudi-led coalition operating against Houthi rebels in Yemen. What began as infighting among various centers of Yemeni political power has evolved into a proxy war between the Saudi-led coalition and Iran. I am deeply troubled by the moral and legal implications of U.S. involvement in the region, and will work to ensure that the U.S. upholds the values of freedom, democracy, and human rights abroad.

As the conflict enters its fifth year, the scale of humanitarian devastation in Yemen cannot be understated. On August 2018, the United Nations Office of the High Commissioner for Human Rights recognized the killing of over 6,500 civilians and the wounding of almost 10,500 in Yemen. Recent estimates indicate that out of a total population of 30 million people, approximately 22.2 million Yemeni people require some form of humanitarian assistance, including food relief, health services, sanitation and water monitoring, and housing and protection measures. Both the European Union as well as the Secretary of the United Nations have referred to the on-going crisis as the world's worst humanitarian catastrophe.

The United States must not abdicate its moral leadership in the world. I voted multiple times in support of a resolution which would effectively prohibit U.S. forces from engaging in specific hostilities in Yemen within 30 days until Congress passes an Authorization for the Use of Military Force. As your senator and a member of the Senate Select Intelligence Committee, I will continue to closely monitor the ongoing crisis in Yemen, and work towards peace and security in the region.

Lieutenant Governor Gavin Newsom has long been a supporter of the universal and single payer healthcare concept. He was an early proponent of the Affordable Care Act and envisions a healthcare model for California that includes a single-payer system.

During his time as Mayor, Healthy San Francisco was signed into law. Healthy San Francisco is the city's universal health care program that covers everyone regardless of immigration status or ability to pay. The program covers undocumented San Francisco residents and people who do not qualify for Medi-Cal. It also provides financial assistance for those who qualify for subsidies through Covered California, but still cannot afford to purchase healthcare on their own. Thank you for contacting the Office of Lieutenant Governor Eleni Kounalakis regarding federal access to California Department of Motor Vehicle (DMV) records.

Under AB 60, undocumented individuals are able to drive in California and obtain a driver's license under the same rules as citizens. Under the DMV's policies, records of individuals with AB 60-mandated driver's licenses are not kept separately from citizens' records. This means that they are searchable by federal law enforcement agencies. Please note that these records do not indicate whether an individual is in the U.S. legally or not.

Thank you for contacting the Office of the Attorney General regarding your consumer complaint. Often it is only through letters from concerned and responsible citizens that our office becomes aware of consumer problems.

Complaints are used to develop information about patterns of business activity which might indicate the need for formal investigation or law enforcement action by our office. Complaints often bring early warning of what promises to be a pervasive scam or systematic violation of California law. If a pattern is discovered, what originated as a private dispute may become a matter of broad public interest and thus warrant intervention by our office under California consumer protection laws.

We do want to inform you, however, that our office is prohibited by law from representing individual citizens in legal matters. We do, within the limits of our resources, bring lawsuits for violations of California law in cases of statewide significance. However, our role in any legal action against a company is on behalf of all of the people of California.

Please be assured that your information will be retained in our consumer files and is of importance in helping this office take appropriate action to protect consumers.

Dear Mr. Babson:

I am in receipt of your letter dated April 18, 2017, regarding the militarization of policing and Urban Shield training. After review of your letter, I offer the following responses to your concerns.

I disagree with your initial premise that assumes law enforcement is being militarized. The equipment and training that I provide to my staff is equipment specifically used in law enforcement; we have no military equipment. The military does not work and has not worked with local law enforcement during any of our responses, which have saved lives.

You indicated law enforcement has military style equipment. What type of equipment; you do not specify. I can assume you mean ballistic vehicles, long rifles and our utility uniforms. All of these items have a specific law enforcement use and they add to the safety of our personnel. Certainly, we do utilize this equipment, but only on mission specific incidents. I am very aware of the concerns of many Alameda County residents; and, we limit the use of such items until, and only when, the need arises.

You make mention of SWAT, which in the Alameda County Sheriff's Office is our Special Response Unit (SRU) utilization during raids. Each of our operations are preplanned and a document is prepared which is reviewed by multiple management personnel. Each SRU drug operation is conducted after the issuance of a search warrant authored and signed by a Superior Court Judge. Each operational plan for an SRU drug raid is reviewed for a "threat level." Only when the threat level reaches a certain criteria, is the use of specialized equipment approved.

Not knowing if you have experience in the execution of narcotics warrants, I would like to explain some of our reasoning. Our Special Response Unit is trained to move as a team and to quickly apprehend the known suspects. These missions are inherently dangerous for law enforcement personnel. I have heard previous arguments from others that law enforcement uses special tactics on low-level drug offenders. These characteristics of our enforcement actions are very unfair. The arguments failed to include the number of handguns, rifles and other weapons recovered from these offenders, even multiple guns at the same location from multiple suspects.

Our Urban Shield training is far more than a competition. We train First Responders from a number of various disciplines. Included in the training are personnel from law enforcement, fire, medical teams, communication teams, emergency mangers and more. This training is utilized for a coordinated response to a terrorist attack, and man-made or natural disasters within the greater Bay Area. At the same time, we are training with new technologies and equipment that would be utilized in any disaster. You, being a Berkeley resident should be aware of the Oakland/Berkeley Hills fire in 1991. That tragic event showed many gaps with the equipment, training needs, communication, and responses. We train to limit the gaps and have a well coordinate response. Urban Shield has created positive bonds and a collaborative response framework between regional first responders, local and regional management agencies, numerous critical infrastructure, public and private sector stakeholders, and state and federal agencies.

As you suggested, our focused training is also greatly beneficial to our "actual demands of the jobs." Much of the technology and equipment we use allows our personnel to do their daily job more effectively and safely which results in better service to the communities we serve.

Sheriff Ahern received your letter dated September 23, 2018, and wants to thank you for your kind words. Since Sheriff Ahern will be attending meetings outside of Alameda County,he has asked me to respond to you.

As you may know, there are a number of county agencies which are eliminating various fees associated with the criminal justice system. The Sheriff's Office will be partnering with the District Attorney, the Probation Department and the Public Defender's Office in this effort. In our case, we will be eliminating the fees charged to individuals who participate in our Work Alternative Program.

Fees associated with the Work Alternative Program were originally designed to accomplish two objectives:

- 1. To provide an incentive for the convicted individual to fully participate in the program given the fact that there was a personal financial investment.
- 2. To help offset the costs associated with providing the program.

Since the Work Alternative Program is a voluntary option which may be incorporated into the sentencing process by the judge handling each case, participation fees are fully disclosed to the potential participant to allow a decision based on all of the facts. The Sheriff's Office has always funded the difference between the amount collected in fees and the actual costs of the program. In general, the costs which are not covered by fees exceeds \$750,000.00 per year. The loss of the fee revenue (approximately \$350,000.00 per year) will necessitate a reduction in the number of available positions in the Work Alternative Program, unless the Board of Supervisors provides additional funding.

The Sheriff's Office believes in alternatives to custody and is committed to the re-entry process. We offer a wide variety of programs both in and out of custody to men and women who express the desire to become productive members of society.

I received your letter urging me to not use county law enforcement resources to enforce national immigration laws. I understand that you are opposed to the efforts of the Federal government under the President Trump administration to enforce federal immigration law.

The Alameda County Sheriff's Office does not conduct any front-line immigration enforcement. The Sheriffs of the State of California do not wish to act as immigration police, nor will my agency. No local law enforcement agency in Alameda County conducts immigration enforcement. The jurisdiction to do such enforcement falls under the authority of the Immigration and Customs Enforcement Agency.

The California State Victim Notification service (VINE) helps victims of crime obtain information about the custody of their offender and is provided by this office and the California Department of Corrections and Rehabilitation (CDCR). VINE is a free service that is available 24-hours a day, seven days a week. The Alameda County Sheriff's Office was the first agency to implement the VINE system. VINE is designed to protect victims of crime and is not intended to be a tool for ICE immigration enforcement.

The Alameda County Sheriff's Office works very hard to maintain public safety and build trust in our communities. We are required to follow all State and Federal laws. Thank you for your letter regarding your concerns on police militarization. As you may know, last year we established an ad-hoc subcommittee on Urban Shield, to evaluate our participation in Urban Shield and the Northern California Regional Intelligence Center (NCRIC). We are in the closing stages of this subcommittee and aim to present our findings to the full Council in the summer. It is my intention to leave Urban Shield, and I want to move away from these militarized trainings and instead focus on disaster preparedness trainings. The City Council has made it clear that we do not want to have militarized equipment. I agree that the presence of such visually militarized gear is detriment to building community trust.

Yesterday, the Alameda County Board of Supervisors voted to end Urban Shield in its current format after 2019. They will also begin a year long process looking into alternatives, and I believe the work we have been doing in Berkeley helped contribute towards the board's decision.

On a final note, if you wish to provide public comment to the Subcommittee on Urban Shield, the meetings are open to the public. The next meeting is tentatively scheduled for Thursday, April 26<sup>th</sup> at 12:30pm at 2180 Milvia Street.
