Dear Mr. Babson,

Thank you for taking the time to express your views regarding healthcare policy.

There are significant challenges in healthcare markets, including reduced competition and rising costs that threaten both family and government budgets. Obamacare has complicated these challenges, causing health insurance premiums for individuals and small businesses to increase drastically while choices dwindle. That is why we must make reforms that improve affordability, protect coverage for pre-existing conditions, expand choice, increase access, and encourage quality healthcare and innovation.

My Administration has vastly expanded affordable insurance options, which can be up to 60 percent less expensive than Obamacare plans for many Americans. We have taken this action in order to bring down premiums for consumers and give millions of Americans a broader range of affordable coverage choices and greater control over how to finance their healthcare needs.

In December 2017, I was pleased to repeal the burdensome individual mandate penalty, which fined Americans for not purchasing insurance coverage they did not want or could not afford. My Administration will continue to work with Congress to pass legislation that takes the power over healthcare out of Washington and returns it to the American people. We will ensure that Americans with pre-existing conditions have access to coverage.

We are also working to make our healthcare system fairer. The Food and Drug Administration approved more low-cost generic drugs in my first two years than ever before in the history of our country, resulting in a decline in drug prices for the first time in 50 years. I also signed into law legislation ending the terrible “gag clauses” that prevented pharmacists from telling patients about cheaper options at the pharmacy counter. Additionally, I signed an Executive Order to promote price and quality transparency in American healthcare, and we have sent a list of principles to Congress to guide lawmakers in developing legislation that will limit surprise medical billing.

Further, we are fighting to ensure all Americans have the healthcare they deserve. I signed into law “Right to Try” legislation, giving terminally ill patients expanded access to care and treatment. I also announced a plan to invest \$500 million in pediatric cancer research over 10 years, and I signed an Executive Order that will significantly increase the supply of kidneys available for transplant. Moreover, I signed into law a \$1 billion increase in funding for critical Alzheimer’s research, and we have launched a campaign to end the HIV/AIDS crisis in America.

Thank you for taking the time to express your views regarding the opioid crisis.

Opioids are having a devastating impact on public health and safety in communities across our Nation. In 2017, more than 70,000 Americans, or nearly 200 people each day, died from a drug overdose, with the majority of deaths involving an opioid.

In 2017, high-dose opioid prescriptions fell by 16 percent and the number of first-time heroin users ages 12 and older fell by more than 50 percent. To strengthen our response to the opioid crisis, I released my Initiative to Stop Opioid Abuse. This Initiative is designed to reduce the demand for drugs through education, awareness, and preventing over-prescription, while also cutting off the flow of illicit drugs across our borders and into American communities. As part of this Initiative, I am calling for a one-third cut of nationwide opioid prescription fills over the next three years and working to expand access to evidence-based addiction treatment in all 50 States.

My Administration has worked with Congress to secure more than \$6 billion in new funding over two years to help combat the drug abuse and opioid crisis through prevention, treatment and recovery services, interdiction, and law enforcement efforts. Additionally, we have increased funding for opioid and pain research from \$600 million to \$1.1 billion.

I also signed into law the overwhelmingly bipartisan SUPPORT Act, the largest legislative effort in history addressing a single drug crisis. This legislation will expand access to evidence-based treatment, protect our communities from illicit drugs, invest more in sustained recovery, bring those in treatment and recovery back into the workforce, and raise public awareness of the dangers of illicitly imported synthetic opioids. It will also support the most vulnerable victims of the opioid crisis by allowing State Medicaid programs to cover healthcare services for infants suffering from neonatal abstinence syndrome in pediatric recovery centers.

To help reduce the supply of illicit drugs in our country, the Department of Justice (DOJ) has started to expand its Opioid Fraud and Abuse Detection Unit's efforts to prosecute corrupt or criminally negligent doctors, pharmacies, and distributors. Additionally, the DOJ will now seek the death penalty against drug traffickers where appropriate under current law. Further, I have called on Congress to pass legislation that reduces the threshold amount of drugs needed to invoke mandatory minimum sentences for drug traffickers who knowingly distribute illicit opioids lethal in trace amounts. To stop the flood of fentanyl at its source in China, I secured agreement from President Xi of China to tighten controls on production of this poison.

Thank you for taking the time to express your views regarding Federal spending and my fiscal year (FY) 2020 budget proposal.

With our national debt reaching a record high of \$22 trillion and growing rapidly, our country's current fiscal path is unsustainable. My 2020 budget provides a clear roadmap for Congress to bring Federal spending and debt under control. We owe it to future generations to stop wasteful spending, get our national debt under control, and focus the Federal Government on what matters most—protecting the Nation. In order to defend our country and assure the sustainability of programs that the American people rely on, we must make these difficult decisions.

A fundamental responsibility of the Federal Government is to protect the homeland. For this reason, my budget makes a border wall a national priority by requesting \$8.6 billion for its construction. As we continue to address the crisis at our Southern border, we must ensure a barrier is built to prevent drugs, terrorism, and crime from entering the United States. My budget also requests \$750 billion for our national defense, a 5 percent increase over the 2019 level. This funding supports the National Security Strategy and National Defense Strategy, building on the major gains we have already made throughout the world.

For decades, American workers have paid into programs, such as Medicare, with the expectation that they will receive their benefits once retired. I am committed to ensuring that the Federal Government honors the deal made with American workers. For this reason, my budget proposes steps to strengthen and protect programs for our seniors.

My budget also focuses on helping working families find a path to a better future by supporting their efforts to balance work and family responsibilities. It proposes a one-time mandatory investment of \$1 billion for States to build the supply of care and stimulate employer investments in child care for working families. Additionally, my budget includes a proposal to provide paid family leave to new parents, including adoptive parents, so that all families can take time to recover from childbirth and bond with a new child.

The Tax Cuts and Jobs Act of 2017, which I signed into law on December 22, 2017, is the first overhaul of our country's tax code in more than 30 years and provides \$5.5 trillion in gross tax cuts to fuel our economy. It lowered the corporate tax rate from 35 percent, the highest in the developed world, to 21 percent, placing American businesses on a level playing field. As a result of this historic tax reform, we are already seeing investment and jobs flow back into the United States from overseas. Additionally, more than 400 companies across the country have announced bonuses, wage increases, or increased contributions to employee retirement plans, among other investments in their businesses and workforce.

My Administration is delivering on its promise to cut unnecessary and burdensome regulations that hamper economic growth. I signed an Executive Order instituting a "one in, two out" policy to require the repeal of at least two existing regulations for each new one that is issued. And for fiscal year 2018, Federal agencies have committed to instituting at least three deregulatory actions for every new regulation.

Additionally, we must have responsible controls on the future entry of foreign workers to protect jobs and wages for existing United States workers of all backgrounds. I have issued an executive order to help accomplish this goal, as I promised during the campaign.

Further, we have achieved a record reduction in illegal immigration on the southern border, an effort that requires constant vigilance against a wide array of threats and challenges. We are also taking action to confront unlawful sanctuary city jurisdictions that dangerously shield criminal aliens. Crucially, we have also begun planning and preparations for the border wall which we need to stop the trafficking of drugs, guns, weapons, and people.

If we continue to enforce our laws and protect our communities, families, and struggling workers, we will reduce our deficit, increase incomes, and make our communities safer for each and every American—present and future.
